#### CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003

#### Direction under Section 12(2)

ACTING under the powers vested in it by Section 12(2) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs all manufacturers, importers, distributors and traders that they shall not manufacture, import, distribute, store or sell or display for sale, expose for sale or offer for sale, wholesale or retail, products/items of operating voltage not exceeding 250V and listed below, unless the said products/items bear the SLS Product Certification Mark issued by the Sri Lanka Standards Institution.

**CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003**

**Direction under Section 12(2)**

ACTING under the powers vested in it by Section 12(2) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs all manufacturers, importers, distributors and traders that they shall not manufacture, import, distribute, store or sell or display for sale, expose for sale or offer for sale, wholesale or retail any electrical appliance of operating voltage not exceeding 250V, unless it carries an electrical plug conforming to SLS : 734 Part 1.

This Direction shall come into effect from 01st January, 2019
