
**SUPPLY OUTAGES WITHOUT PRIOR NOTICE**

Since today (3<sup>rd</sup> February 2020) morning, this Commission have been receiving numerous complaints from the consumers from the localities Wattala, Ja Ela, Kandana, Kelaniya, Maharagama, Boraesgamuwa, Nugegoda, Mirihana and Hikkaduwa regarding the sudden power failures of durations two to two and half hours. Having observed the nature of complaints, the Commission is of the view of those interruptions are not falling in to the category of maintenance of the system in respect of which prior notice is given to the general public.

As per section 10 of the Condition 30 of the Electricity Transmission and Bulk Supply License (License Number - EL/T/09-002) issued to the Ceylon Electricity Board, Licensee is required to obtain prior approval of the Commission for every scheduled interruption of electricity supply other than the interruptions necessary due to maintenance.

Therefore, you are hereby informed to submit a report to the Commission on the above-mentioned interruptions without prior notice.
