## GUIDELINE TO FILL THE APPLICATION FORM FOR AN EXEMPTION FROM THE REQUIREMENT TO OBTAIN A DISTRIBUTION LICENCE

## INTRODUCTION

- The said Application is prepared based on "The Electricity (Applications for Licences and Exemptions) Regulation, 2009 which was gazetted in Extraordinary Gazette No. 1,617/34 - THURSDAY, SEPTEMBER 03, 2009.
- You are required to carefully read all the instructions given in pages 1A, 2A and 3A of the "Regulations" section (item number 1 to 7) of aforesaid Gazette before fill the Application.
- 3. Application contains main three parts namely;
  - a. Schedule F Part I
  - b. Schedule F Part II
  - c. Schedule G Declaration
- 4. Applicant may download the Microsoft Word format/PDF format of the Application and fill the same with handwriting or (computer) typing.
- 5. For handwritten Application, it is necessary that all the handwriting should be neat and clear.
- 6. Instructions to be followed for each item/question when filling the Application, are given in tabulated form in page 4 to 6 of this document itself.
- 7. Required spaces are given by the Application itself in order to provide answers for each item/question of the Application but if the provided space is not adequate to answer, Applicant may use additional papers and those papers should be annexed at the end of the Application. Also, Applicant has to annex additional supporting documents (approvals, letters, maps, agreements, etc.) as indicated in the Application. All such annexures should be clearly labelled with an annexure number (as Annexure 1, Annexure 2, ....) and that labelled annexure number should be mentioned in the provided space at the corresponding item/question of the Application.

- 8. All the fields of the Application are mandatory to fill and if any field is not relevant to the Applicant, state it as "NA" (not applicable)
- 9. With respect to all approvals/agreements to be provided along with the Application, the name of the Applicant, address of the Applicant and the address of the Premises should be identical with the information provided by the Applicant under section 1,3 and 7 of the SCHEDULE F - PART I of the Application.
- 10. Application along with the other attachments (additional papers, annexures, maps, documents, approvals, etc.) should be properly arranged and bounded together and should be submitted to the PUCSL as single file along with the copy of the payment slip of the Application fee (as per section 6(1) of the page 2A of the "Regulations" section of aforesaid Gazette). Said payment slip (copy) should be pasted in the provided space at the end of the Application.

That agreement should clearly identify;</li> <li>1) all the necessary electrical system related operation and maintenance work to be done</li> <li>2) names of the technical staff responsible for such work along with their designations, qualifications and experiences</li> <li>3) if above item 1 and 2 are not available with the said agreement, the hired party (party to be hired) should confirm above requirements by a letter to the Applicant and Applicant should attach such documents along with the Application</li> </ul>
